Clemelin Smith is the incorporator of ESTHER'S TRENDS: Clothing and Assecories.

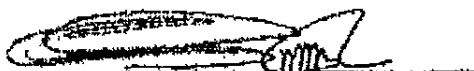
#### ARTICLE VIX: BYLAWS
