The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is: **KIDS INTENSIVE THERAPY, INC.**

ARTICLE TWO

The term of existence of the corporation is perpetual.

ARTICLE THREE

The purposes for which the corporation is organized are:

To engage in the practice of physical therapy; to perform physical therapy assessments and treatment of any disability, injury, disease or other health condition of human beings; or the prevention of such disability, injury, disease or other condition of health and rehabilitation as related thereto, as provided for by law and pertinent regulations.

To engage in the transaction of any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation has authority to issue is 1,000, all of which shall be common shares with par value of \$1.00.

ARTICLE FIVE

The address of the initial Registered Office of the corporation is 14902 SW 158th Place, Miami, FL 33196 and the name of the Registered Agent at such address is SUSAN D. PALACIO.

ARTICLE SIX

The business of the corporation shall be managed by the stockholders of the corporation rather than by a Board of Directors.



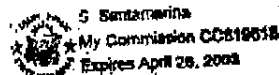
