
SECOND: The date of each amendment's adoption was June 11, 2003. However retroactive effective date shall be June 11, 2003.

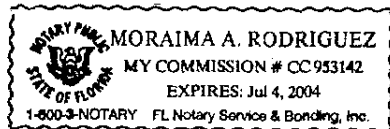
