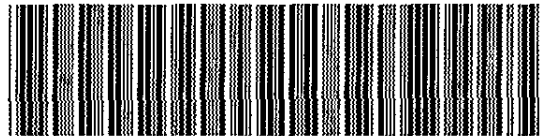

ARTICLE I - NAME

The name of this professional association is LAW OFFICE OF ISABELLE AZRIA, P.A.

ARTICLE II - CORPORATE EXISTENCE


