




CERTIFICATE OF INCORPORATION

OF YO-YO INVESTMENTS II, INC.

ARTICLE IV

The amount of capital with which this corporation may begin doing business shall be not less than FIVE HUNDRED DOLLARS (500.00).

ARTICLE IX
