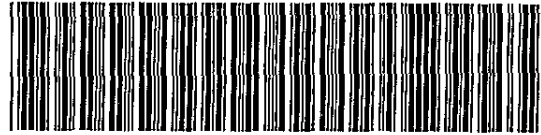


1. The name of the corporation is INSURED REAL ESTATE TITLE SERVICES, INC.
