# ARTICLES OF INCORPORATION of YENRAC MANAGEMENT COMPANY

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

## ARTICLE I

## <u>NAME</u>
