**ARTICLE I**

#### ARTICLE XII



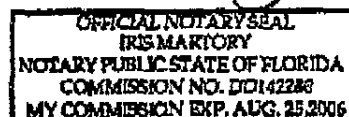
