## ARTICLE I - NAME:

The name of this corporation is: VERN'S AUTO PARTS & CREPAIR, INC., hereinafter referred to as the "Corporation".

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

# ARTICLE III - PURPOSE:

ARTICLE II - DURATION:
