Articles of Incorporation

ARTICLE I

NAME

The name of the corporation shall be:

The general nature of the business and the objects and purposes to be transacted and carried on by this Corporation shall be:

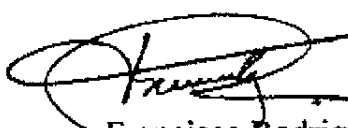

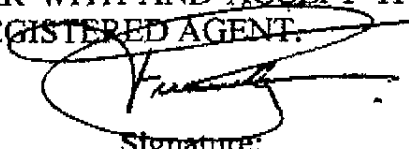
