



ARTICLES AND INCORPORATION

OF

ARTICLE I - NAME

Name of this Corporation is ALAFAYA HOLDINGS, INC.

expenses, including but not limited to the reasonable costs and expenses incurred by him/her in connection with the defense of, or for advise concerning any claim asserted or proceeding brought against him/her by reason of his/her being or having been an officer of the Corporation or shareholder of the Corporation who exercised management authority, whether or not wholly owned or by reason of any act or omission to act as such shareholder or officer. The formal right of indemnification shall not be exclusive of any other right to which any shareholder or officer may be entitled as a matter of law. Shareholders acting in their management capacity shall be entitled to any right of indemnification available to directors as a matter of law.
