ARTICLES OF INCORPORATION

OF:

ARTICLE I NAME

The name of this corporation is Terry's Bobcat Services, Inc.



ARTICLE IL PURPOSE

This corporation is organized for the following purposes:

a. To engage in any or all lawful business for which corporations may be incorporated under the laws of Florida.
