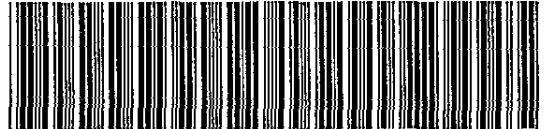


ARTICLE VII

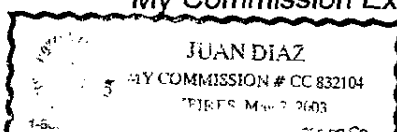
