

#### ARTICLE I - NAME

The name of the corporation is C.J.'s Land Maintenance, Inc. at 290 Treu Terrace NW, Palm Bay, FL 32907 (Principal Office of Registered Agent).

#### ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
