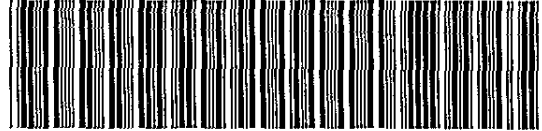

**Articles of Incorporation
OF
TOC Enterprises, Inc.**

The undersigned incorporator of these Articles of Incorporation, natural person, competent to contract, hereby associates herself together, to form a corporation under the laws of the State of Florida.

Article I, Name

The name of the corporation is:

TOC ENTERPRISES, INC.

Article II, Nature of Business

The corporation may engage in any activity or business permitted under the laws of the United States of America, except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone, of cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.

Article III, Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100,000 (One Hundred Thousand) shares of common stock with a nominal or par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the Board of Directors. There shall be no other class of stock. The incorporators may, by contract, restrict the alienability of this stock. An endorsement shall be made upon each certificate of stock indicating the existence of such contract. This provision shall not prevent the personal representative of deceased stockholder or the guardian or an incompetent stockholder from taking possession of such stock in accordance with the requirements of law until such stock can be sold or otherwise disposed of.

Article IV, Initial Stock

The amount of capital with which this corporation will begin business is \$100,000.00 dollars.

This corporation shall have five (5) directors initially. The number of directors may be increased or diminished from time to time, by the By-laws, adopted by the stockholders.

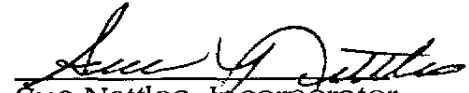
