The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby organizes and incorporates a corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of the corporation is: Orna Processing Inc.

**ARTICLE II**

**NATURE OF BUSINESS**

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory, or nation. The specific nature of business of this corporation is to process Mortgage Services and provide other lending processing services in accordance with Florida law.

**ARTICLE III**

**CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is Five Hundred (500) shares of common stock having a nominal or par value of One Dollar (\$1.00) per share.

This corporation shall exist perpetually.

## **ARTICLE VII**

### **ADDRESS**

## **ARTICLE VIII**

### **DIRECTORS**

The rights accruing to any person under the foregoing provisions shall not exclude any other right to which he/she may be lawfully entitled, nor shall anything therein contained restrict the right of the corporation to indemnify of reimburse such person in any proper case even though not specifically provided for herein.
