The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida

The corporation shall be engaged in the business of wholesale and/or retail brokerage printing and/or any other lawful business permitted under the laws of the United States and the State of Florida.
