As per our telephonic conversation on September 21, 2007 regarding the payment of the 2007 Annual Report we are writing this letter to appraise you of the facts for the untimely filing for this 2007 Report.


We did not receive the "Annual Report Notice" that is usually due on May 1<sup>st</sup> of each year as per our records, but instead we received a "Notice of Intent to Dissolve" (see exhibit A) stating the following:

*"This will serve as your 60 days notice that the business entity listed on this postcard will be administratively dissolved/revoked and an additional reinstatement fee will be due if the annual report is not properly filed and the appropriate fee paid by September 5, 2007."*

After seeing this notice we immediately sent a check with the proper Annual Report fee before the September 5, 2007 as stated in the Notice of Intent to Dissolve to avoid the administrative dissolution/Revocation of our company but this check apparently was lost or misplaced; we check our bank records and no charge was made for this check. We contacted your office and spoke with Mr. Tyrone and he advised us to re-mail a new check before is long past due and the 2<sup>nd</sup> check was sent to your office.

Under the current circumstances and the misfortune of a lost check we kindly ask you to accept our document and our 2<sup>nd</sup> check for the payment of the Annual Report administrative fee that was sent to your office but returned to us last week. We have never had in the past any issues of payment or late filing with The Florida Department of State Division of Corporations and we respectfully ask you to grant our petition for accepting our filling due to the circumstances explained above since we are a very small woman owned corporation and our efforts are great to keep our company afloat.
