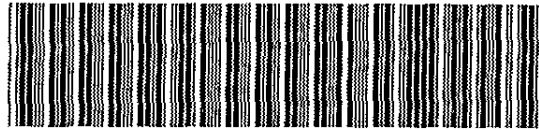

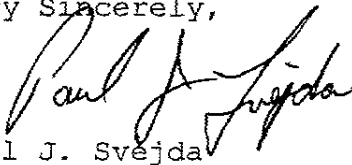

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST: The name of the corporation is Jordan Hunter, Inc.
- SECOND: The period of its duration is perpetual
- THIRD: The purpose(s) for which the corporation is organized are importing all types of products and items from China and Asia in general to the U.S.A. and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of common stock having no par value or amount of par value each.
- FIFTH: The corporation will not commence business until at least One Thousand Dollars (\$1000.) have been received by it as consideration for the issuance of shares.
- SIXTH: Cumulative voting of shares of stock is not authorized.

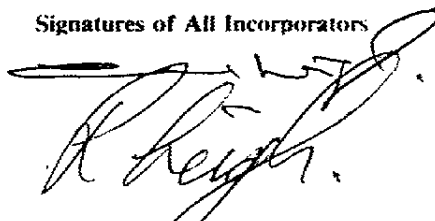

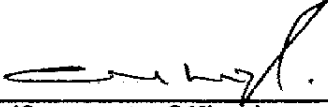
