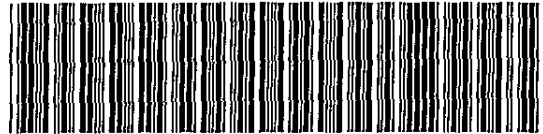

ARTICLES OF INCORPORATION

The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporation act hereby adopts the following Articles of Incorporation.




