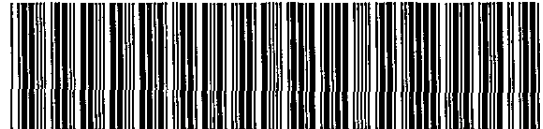

ARTICLE I. NAME

The name of this corporation shall be Robbins & Feldman, P.A.

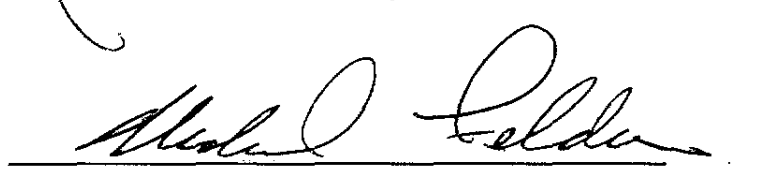
