AMENDMENT TO THE ARTICLES OF
INCORPORATION
OF

BEFORE ME, the undersigned authority, this day personally appeared Jaime Rey Soto, Alvaro Villalonga, Giovanna Rey, and Miguelangel Cabrera who first by me being duly sworn deposes and says:

That pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

First: Be it amended that Article VI of the original Article of Incorporation has been changed to include Osvaldo J. Diaz as Director of the company.

Second: Be it amended that the corporation officers are hereby changed and shall hereafter be known as Jaime Rey Soto as President/Director, Alvaro Villalonga as Vice-President/Director, Giovanna Rey as Secretary/Director, Miguelangel Cabrera, and Osvaldo J. Diaz as Director of the corporation.

Third: The date of the change of officers shall be effective on the date filed in the Office of the Secretary of State, Division of Corporations, State of Florida. This is adopted the 16th day of May 2003.
