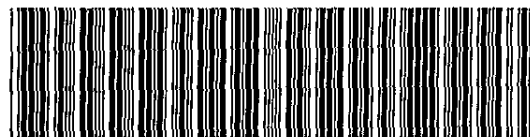

ARTICLE I.

NAME

The name of this corporation is Walker Concrete Consulting, Inc.

ARTICLE II.

PRINCIPAL OFFICE

The initial principal office address of this corporation is 1358 Oaklanding Lane, Orange Park, Florida 32003, and the initial mailing address is the same.

ARTICLE III.

COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV.

CAPITAL STOCK

This corporation is authorized to issue ten thousand (10,000) shares of common stock with a par value of one cent (\$.01) per share. 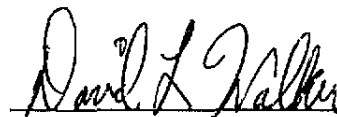
