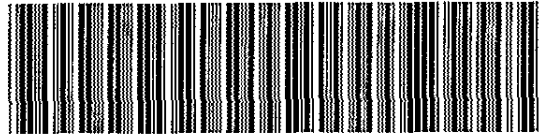

ARTICLES OF INCORPORATION

OF

AC Brokers, Inc.

ARTICLE I - NAME

The name of this corporation is AC Brokers, Inc.

ARTICLE II - DURATION

ARTICLE XI-AMENDMENT




