ARTICLES OF INCORPORATION OF COSMOPOLITAN U.S.A., Inc.

The undersigned, desiring to form a corporation for profit pursuant to the laws of the State of Florida, does hereby certify as follows:

ARTICLE ONE

The name of this corporation shall be:

COSMOPOLITAN U.S.A., Inc.

ARTICLE TWO

The general nature of the business to be transacted by the corporation and the purpose for which it is formed are to be as follows:

- (a) **Import/Export and retail sale** in the State of Florida pursuant to the laws of Florida and the U.S.A.
