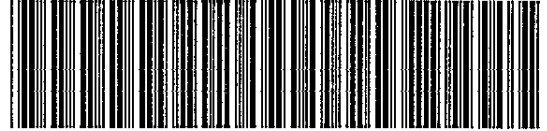

The undersigned, KOSTADINOS TSAVARIS, does hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME**

The name of this corporation shall be AMERICAN INDUSTRIAL PAINTING, INC.

**ARTICLE II**

**PRINCIPAL OFFICE AND MAILING ADDRESS**
