ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED INCORPORATOR for the purposes of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is FRANCES SANDLER SILVER, M.D., P.A.

This corporation is to exist perpetually.
