ARTICLES OF INCORPORATION OF SRI SAI, INC.



The undersigned, desiring to form a corporation under the Florida General Corporation Act, makes and subscribed to the following Articles of incorporation.

ARTICLE I

The name of this corporation is SRI SAI, INC.

This corporation shall have perpetual existence.


