ARTICLES OF INCORPORATION OF NAP HOME IMPROVEMENT SERVICES, INC.

ARTICLE I NAME

The name of this Corporation is NAP Home Improvement Services, Inc.

ARTICLE II DURATION

This Corporation shall have perpetual existence. The effective date of this Corporation shall be the date of filing of these Articles.

ARTICLE III PURPOSE
