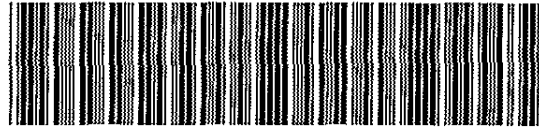



ARTICLES OF INCORPORATION

of

AVON INVESTMENTS, INC.

Article I -- Name

The name of this corporation is AVON INVESTMENTS, INC.

Article II -- Duration

This corporation shall exist for a perpetual period of time.

Article III -- Purpose

This corporation is organized for the purpose of buying, selling, leasing, improving real property of all types and kinds , and transacting any and all business which may be permitted under the laws of the State of Florida, and approved by the Board of Directors.




