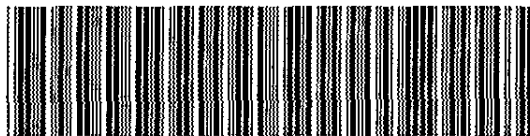

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is: UNTAMED TRANSPORT INC.

ARTICLE II DURATION

The term of existence of the corporation is perpetual.


