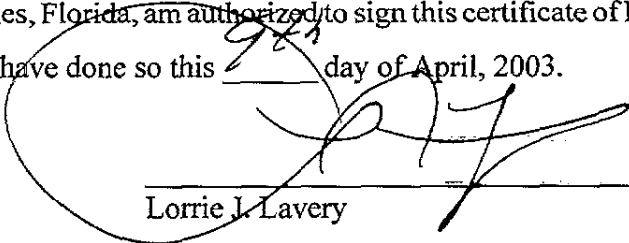

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be Lavery Rental, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 3139 Leeward Lane, Naples, Florida 34103. The mailing address of the Corporation shall be c/o Lorrie J. Lavery, 3139 Leeward Lane, Naples, Florida 34103.

ARTICLE III - DATE OF EXISTENCE

This Corporation shall exist perpetually, commencing on December 28, 1994.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred thousand (100,000) shares of voting common stock having a par value of One Cent (\$0.01) per share.

ARTICLE V - INITIAL REGISTERED OFFICE

AND REGISTERED AGENT

The initial street address of the registered office of this Corporation in the State of Florida shall be 3139 Leeward Lane, Naples, Florida 34103. The Board of Directors may from time to time move the registered office to any other address in Florida. The name of the initial registered
