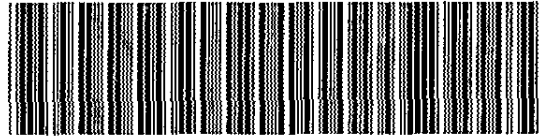




1. The name of the corporation shall be: Harp International, Inc.
