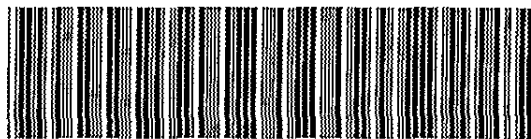

ARTICLE ONE
