- 1. This document shall represent the Articles Of Amendment To Articles Of Incorporation Of Mattress Liquidators Of Pompano Beach, Inc., a Florida Corporation.
- 2. <u>Article VI. Registered Agent</u> The text of the Amended Article VI of Mattress Liquidators Of Pompano Beach, Inc. shall read as follows:
  - "Article VI. Registered Agent The name and address of the Registered Agent of the Corporation is Nancy Iona, 2099 West Atlantic Boulevard, Suites 204-206, Pompano Beach, Florida 33069."
- 3. <u>Article VII. Registered Office</u> The text of the Amended Article VII of Mattress Liquidators Of Pompano Beach, Inc. shall read as follows:
  - "Article VII. Registered Office The initial registered office of this Corporation shall be: 2099 West Atlantic Boulevard, Suites 204-206, Pompano Beach, Florida 33069."
- 4. <u>Article VIII. Corporate Offices</u> The text of the Amended Article VIII of Mattress Liquidators Of Pompano Beach, Inc. shall read as follows:
  - "Article VIII. When, and as authorized by affirmative vote given at a meeting or by the written consent of stockholders of record holding at least a majority of the stock, to sell, lease or exchange all of the real and personal property and assets of the corporation, excluding its good will and its corporate business, upon such terms and conditions as the Board of Directors deem expedient."

"Article X. Incorporator - The name and address of the person signing these Articles Of Incorporation is: Nancy Iona, 2099 West Atlantic Boulevard, Suites 204-206, Pompano Beach, Florida 33069."

7. <u>Article XI. Officers</u> - The text of the Amended Article XI of Mattress Liquidators
Of Pompano Beach, Inc. shall read as follows:

"Article XI. Officers - The names and addresses of the officers of this Corporation are as follows: Nancy Iona, 2099 West Atlantic Boulevard, Suites 204-206, Pompano Beach, Florida 33069."
