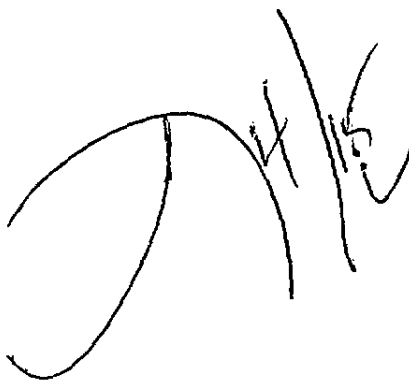

ARTICLE I

NAME OF THE CORPORATION

The name of this Corporation shall be SEAN MANAGEMENT, INC.

PERIOD OF DURATION

The period of duration of the Corporation is perpetual.

ARTICLE III

PURPOSE

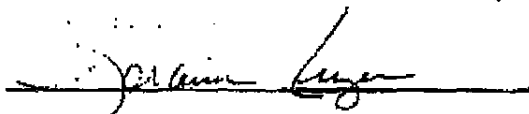
