ARTICLES OF INCORPORATION

OF

ARTICLE I.

NAME

The name of this corporation is CONSOLIDATED EQUIPMENT LEASING, INC.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

DURATION: EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of April 10, 2003.
