## ARTICLES OF INCORPORATION OF K & H TIMBER, INC.

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit under the Florida General Corporation Act.

#### ARTICLE I. NAME

The name of the corporation is K & H TIMBER, INC.

#### ARTICLE II. DURATION

The duration of this corporation is perpetual.

#### ARTICLE III. PURPOSE
