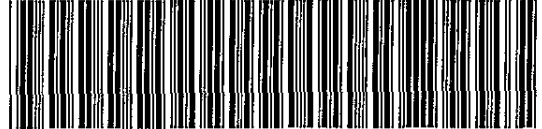


**ARTICLE XI  
AMENDMENT**






