ARTICLES OF INCORPORATION OF

SECALIANT STATE ANCHOR CONSTRUCTION OF FT. MYERS, INC. TALLAMASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the provisions of the FLORIDA GENERAL CORPORATION ACT, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is ANCHOR CONSTRUCTION OF FT. MYERS, INC.

ARTICLE II

The duration of the corporation is perpetual.

The corporation will engage in the operation of a masonry, concrete pumping, concrete finishing and cleanup organization to assist in the construction or modification of any structure or to enter into any other business activity authorized under the laws of the State of FLORIDA or of the laws of the United States.

ARTICLE IV

The Corporation shall have authority to issue one (1) class of Capital Stock which shall consist of five thousand (5,000) shares of one dollar (\$1.00) PAR value Common Stock.

ARTICLE V
