

ARTICLES OF INCORPORATION OF NUPAY, INC.

ARTICLE I - NAME AND MAILING ADDRESS

The name of this corporation is NuPay, Inc., and the mailing address of this corporation is 8601 4th Street North, Suite 300, St. Petersburg, Florida 33702.

ARTICLE II - DURATION

This corporation shall have perpetual existence.
