**ARTICLE I.  
NAME**

The name of this corporation is BOAT DOCUMENTS, INC.

**ARTICLE II.  
PRINCIPAL OFFICE**

The principal office of this corporation and the mailing address of this corporation is 742 2<sup>nd</sup> Avenue South, St. Petersburg, FL 33701.

**ARTICLE III.  
DURATION**

This corporation shall exist perpetually.

**ARTICLE IV.  
PURPOSES**
