ARTICLES OF INCORPORATION

OF

MILLENIA REAL ESTATE CORPORATION

ARTICLE I. CORPORATE NAME

The name of this corporation is MILLENIA REAL ESTATE CORPORATION, and has its principal place of business at 916 S. Ivey Lane, Orlando, Florida 32811.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida and this Corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.
