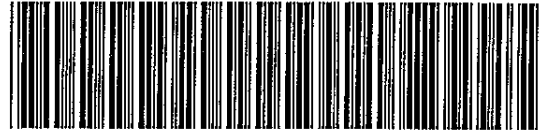



**ARTICLES OF INCORPORATION  
OF  
IDEAL HOME CONSTRUCTION, INC.**

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I: NAME AND PRINCIPAL OFFICE ADDRESS**

The name of this corporation is IDEAL HOME CONSTRUCTION, INC., and its principal office address is 1415 Lansing Drive, Pensacola, Florida 32504.

**ARTICLE II: DURATION**

This corporation shall exist perpetually, commencing upon the date of filing of these Articles of Incorporation.

**ARTICLE II: PURPOSE**

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV: CAPITAL STOCK**
