ARTICLES OF INCORPORATION

OF

ARCADIA CAR WASH, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

1. The name of the corporation is

2. The general purpose or purposes for which the corporation is initially organized is the operation of a car wash, and to transact any and all business allowed by law in the State of Florida.
