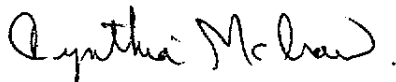

The undersigned incorporator, for the purpose of forming a professional service corporation under Chapters 607 and 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

Article I

Name

The name of the corporation shall be Pantsari Architecture, P.A.

Article II

Principal Office

The street address and mailing address of the initial principal office of the corporation is 4042 E County Highway 30A, Suite E, Seagrove Beach, Florida 32459.

Article III

Purpose

The purpose for which the corporation is organized is to engage in the business of rendering professional architecture services and all services thereto related, and to transact any and all lawful business permitted for such a professional service corporation under Chapter 607 and 621 of the Florida Statutes.
