# ARTICLES OF INCORPORATION OF OUALITY DRY CLEANING DELIVERY, INC.

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

#### I. <u>Name</u>

The name of the Corporation is Quality Dry Cleaning Delivery, Inc.

#### II. Term of Existence

The date when corporate existence will commence is April 14, 2003 in accordance with Section 607.0203(1) of the Act.

# III. <u>Principal Office</u>

The principal office and mailing address of the Corporation is 166 East Bloomingdale Avenue, Unit #11, Brandon, Florida 33511-8101.

### IV. Capital Stock

The Corporation is authorized to issue 10,000 shares of \$1.00 par value voting common stock, which will be designated Common Stock ("Common Stock").
