In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of this corporation is: Ismail M. Zabih, M.D., P.A..

ARTICLE II

The street address of the principal place of business of the corporation is: 3A Miracle Strip Loop, Panama City Beach, Florida 32407.

ARTICLE III

The specific purpose for which the corporation is organized is: To engage in the practice of medicine as a professional corporation and to own and operate a medical clinic for the purposes of providing medical care and treatment and to furnish related laboratory and clinical services and to do every other act incidental to the corporate purposes which is not forbidden by Florida law.

ARTICLE IV




