1. Amendment Adopted:

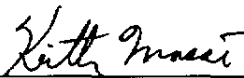
Article I of the Articles of Incorporation is hereby amended in order that the name of the Corporation is hereby changed to: Jewell & Massi, PA.

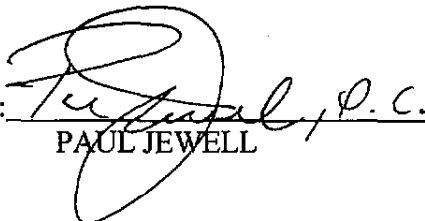
2. The date of adoption for this amendment is January 30, 2006.
