This amendment was made on July 13, 2009 unanimous by vote of the two stockholders of common stock of the corporation.

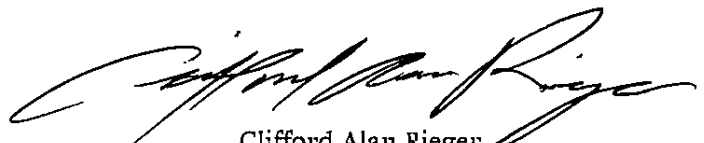
